Dear applicant, we would like to thank you for your interest in Bella Terra.

Applications will be mailed or emailed to applicants who make such a request as a reasonable accommodation.

<u>Completed applications are to be returned to the Bella Terra Managers Office, Monday</u> <u>Friday between the hours of 8:00 am – 4:00 pm</u>. All completed applications will be date and time stamped upon receipt at the leasing office.

All application entries are to be made in ink or typed. Corrections or changes are to be made by drawing a line through the original entry and entering the correct data. Such changes must be dated and initialed by the person making the change. If a question does not apply to your household simply write N/A "not applicable". The application must be completed and signed by the head of household and all household members 18 years of age and older.

Incomplete applications will not be accepted.

Applications will be processed on a first-come, first-served basis.

You will receive a letter from management confirming receipt of your application with a status on where you are on the waiting list. You may also receive a letter with a date, time & list of documents you will need to bring with you on your scheduled appointment date. Application fees are \$46.00 per each household member 18 years of age & older. The maximum charge per household is \$138.00. Please know that placement on the waitlist in no way implies that you will receive an apartment at Bella Terra. Eligibility for housing at Bella Terra is based upon the criteria listed within the resident selection plan.
