Meheula Vista is a master planned, low-income, 55 and over senior affordable rental housing development located in Mililani Mauka on O'ahu. The community encompasses four separate apartment buildings, each containing 75 one-bedroom, one-bath units, and a stand-alone Multi-Purpose building. Meheula Vista provides seniors with an affordable permanent living option, offering supportive services and amenities where residents can "age in place." Catholic Charities social workers are also on-site to assist residents with tasks such as applying for rent and food assistance, senior services, entitlements, and other issues facing the senior population. Utilities are included in the rent.

Applications are currently accepted for the fourth and final phase of Meheula Vista affordable senior rentals. The fourth phase of the Meheula Vista complex includes 75 one-bedroom and one-bath residences.
