Greenfield Commons I brings 100 permanently affordable homes to families rooted in agriculture. This vibrant, garden-style community features modern, energy-efficient apartments, walk-in closets, gathering spaces, a resident garden, and recreation areas, all designed for comfort and connection.

Forty-three homes are set aside for farmworkers through the Farmworker Housing Grant (FWHG) Program. Per Assembly Bill 2024, farmworkers who live or have lived at an Office of Migrant Services (OMS) center in the past 36 months receive priority.


