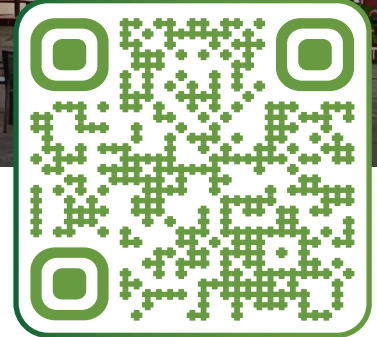

FAIR HOUSING & ACCESSIBILITY INFORMATION
